La UIP es la organización global de parlamentos nacionales. Fue fundada hace más de 130 años como la primera organización política multilateral del mundo, fomentando la cooperación y el diálogo entre todas las naciones. Hoy en día, la UIP está compuesta por 180 parlamentos nacionales miembros y 15 órganos parlamentarios regionales. Paraguay es miembro pleno desde el año 1992. La Unión promueve la democracia y ayuda a los parlamentos a convertirse en instituciones más fuertes, más jóvenes, más ecológicas, más equilibradas en términos de género y más innovadoras. También defiende los derechos humanos de los parlamentarios a través de un comité especializado compuesto por parlamentarios de todo el mundo.

La Asamblea de la UIP se realiza cada seis meses, y esta vez contó con la asistencia de cientos de parlamentarios de todo el mundo, para abordar el tema “Diplomacia parlamentaria: Construyendo puentes para la paz y el entendimiento”. Proporcionó un espacio muy necesario para el diálogo parlamentario y la diplomacia a nivel global, regional y bilateral, como complemento de las Naciones Unidas y otros foros multilaterales.

Los diversos órganos parlamentarios de la UIP centrados en situaciones de conflicto se reunieron, entre ellos:

- **El Grupo de Trabajo de la UIP para la resolución pacífica de la guerra en Ucrania**, que escuchó a los parlamentarios de la Federación Rusa y de Ucrania por separado. Compuesto por ocho destacados parlamentarios de todo el mundo, el objetivo del Grupo de Trabajo fue explorar las contribuciones parlamentarias a los esfuerzos para poner fin a la guerra. También sirvió para el intercambio de información entre los dos parlamentos.
- **El Comité de la UIP sobre Cuestiones de Oriente Medio**, que se reunió para considerar qué medidas parlamentarias tomar en vista del prolongado conflicto en Gaza, con sus desastrosas consecuencias humanitarias. El Comité está formado por 12 parlamentarios con especial experiencia en Oriente Medio.
- **El Grupo de Facilitadores de la UIP en Chipre**, que se reunió para hacer un balance y considerar medidas para resolver la situación en la isla.
- También se desarrollaron reuniones con delegaciones de alto nivel encabezadas por los Presidentes del Parlamento de Armenia y Azerbaiyán, tras la reciente visita del Secretario General de la UIP, Martín Chungong, a la región.

La Asamblea adoptó resoluciones sobre: *Abordar el impacto social y humanitario de los sistemas de armas autónomos y la inteligencia artificial y Alianzas para la acción climática: promover el acceso a energía verde asequible y garantizar la innovación, la responsabilidad y la equidad.*

Se reunieron además todos los diversos órganos parlamentarios de la UIP, incluidos sus cuatro Comités Permanentes temáticos, el Foro de Mujeres Parlamentarias, el Foro de Jóvenes Parlamentarios y el Comité de Derechos Humanos de los Parlamentarios.

En la Asamblea, la UIP también aceptó nominaciones para la edición 2024 del Premio Cremer-Passy, que lleva el nombre de los parlamentarios del siglo XIX William Randall Cremer y Frédéric Passy, quienes fundaron la UIP en 1889, como parte del movimiento por la paz.

En referencia al tema de la Asamblea, los parlamentarios ganadores deben tener un historial excepcional en lo que respecta a la paz y la seguridad. El ganador del Premio 2024, se anunciará en la segunda Asamblea de la UIP del año en octubre.

Previa a la Asamblea, se llevó a cabo la Sesión ordinaria del Grupo Latinoamericano y el Caribe (GRULAC), el viernes 22 de marzo. Se dio inicio, con las palabras de bienvenida de la Presidenta del GRULAC, Diputada Sofía Carvajal (México).

Cientos de parlamentarios de más de 140 países, nos hemos reunido durante esta Asamblea, reconfirmando el compromiso con la diplomacia parlamentaria para apoyar los esfuerzos de paz y revitalizar el multilateralismo a través de la acción parlamentaria.

En la Declaración Final, la Diplomacia Parlamentaria: Construyendo puentes para la paz y el entendimiento, los legisladores reconocimos la importancia del “diálogo y la cooperación interparlamentarios, y el papel único de la UIP como contraparte parlamentaria de las Naciones Unidas”.

La declaración enfatiza que los parlamentarios tienen un papel activo que desempeñar para acompañar y complementar la diplomacia tradicional.

“asegurando que los esfuerzos para negociar procesos de paz, tratados y otros acuerdos internacionales estén arraigados en las necesidades del pueblo”.

En la Asamblea, los dirigentes de la UIP, emitieron una declaración política urgente en nombre de la comunidad parlamentaria mundial pidiendo un alto el fuego inmediato en Gaza, para complementar la resolución del Consejo de Seguridad de las Naciones Unidas que exige un alto el fuego.

La Asamblea de la UIP fue una de las más concurridas de la historia, con más de 700 parlamentarios en Ginebra, incluidos más de 50 presidentes del Parlamento. Alrededor del 36% de los parlamentarios eran mujeres y alrededor del 27% eran parlamentarios jóvenes menores de 45 años.


En un contexto de conflictos prolongados en todo el mundo, la Asamblea brindó un espacio para que los diversos órganos parlamentarios internacionales de la UIP contribuyeran a los esfuerzos de consolidación de la paz, incluido el Grupo de Trabajo para la resolución pacífica de la guerra en Ucrania, el Grupo de Facilitadores para Chipre y el Comité de Cuestiones de Oriente Medio.

En vísperas de la Asamblea, la UIP también actuó como facilitadora de una reunión histórica entre los Presidentes de los Parlamentos de Armenia y Azerbaiyán, que se sentaron por primera vez en un esfuerzo por normalizar las relaciones entre sus dos países. Esa reunión tuvo lugar en la sede de la UIP.

Entre otros resultados, la Asamblea de la UIP también adoptó dos resoluciones importantes:

**Abordar el impacto social y humanitario de los sistemas de armas autónomos y la inteligencia artificial**, insta a los parlamentos a desarrollar legislación nacional para establecer marcos regulatorios que regulen el desarrollo de sistemas de armas autónomos.

La resolución exige un “control humano significativo” sobre los sistemas de armas –como los drones– y la consideración de las implicaciones éticas, legales y de seguridad de los sistemas que funcionan sin control humano y, por lo tanto, potencialmente fuera de las reglas de la guerra y el derecho internacional humanitario.





La Asamblea de la UIP también aprobó una moción que pide una reforma del Consejo de Seguridad de las Naciones Unidas para reflejar mejor las realidades geopolíticas del siglo XXI y hacerlo más democrático y responsable.

El Comité de la UIP sobre los Derechos Humanos de los Parlamentarios también adoptó importantes decisiones con respecto a los casos de parlamentarios de todo el mundo que se encuentran en peligro - incluidos Bangladesh, Egipto, Eswatini, Guinea-Bissau, Israel, Kirguistán, Madagascar, Pakistán, Palestina, Filipinas, Somalia, Türkiye, Venezuela y Zimbabwe.

Nos valemos de la ocasión, para reiterarle nuestro más sincero agradecimiento, por darnos la oportunidad de representar a este Alto Cuerpo Legislativo, ante tan relevante evento internacional.

### Table of votes at the Assembly

In conformity with Rule 29 of the Assembly Rules, the table indicating the number of votes to which delegations taking part in the session are entitled will be distributed at the opening of the Assembly. Delegates are reminded that votes are allocated in accordance with the provisions of Article 15 of the Statutes, which stipulates as follows:

#### ARTICLE 15

1. Only delegates present in person shall have the right to vote.
2. The number of votes to which each Member of the IPU is entitled shall be calculated on the following basis:
  - (a) Each Member of the IPU shall have a minimum of ten votes;
  - (b) Each Member of the IPU shall have the following additional number of votes in relation to the population of its country:

- (c) Any delegation composed exclusively of parliamentarians of the same sex shall have a minimum of eight votes (instead of the 10 for mixed delegations) at the Assembly of the Inter-Parliamentary Union. For delegations entitled to a certain number of additional votes, the overall calculation will be made on the basis of eight votes instead of 10.
3. A delegation may split its votes so as to express the diverse views of its members. No one delegate may record more than 10 votes.

### Assembly documents

The Secretary General has overall responsibility for authorizing the circulation of all official documents for the session.

Before the opening of each session, all meeting documents will be made available to delegates. In keeping with the decision by the IPU governing bodies to reduce the carbon footprint of the Organization and continue to reduce paper waste, only a limited number of documentation sets will be printed for the various sessions of the Assembly.

Delegates who wish to obtain additional copies of documents posted on the IPU website may use the print-on-demand service available at the Typing Pool and Print-on-demand Service for delegates, located on level -1, close to the Internet café. All documents on the 148th Assembly webpage are also posted on the Assembly App.

The Assembly Journal, providing the latest updates on the programme of meetings and other information is available in meeting rooms and at the Information Desk, as well as on the 148th Assembly webpage and Assembly App.
